2. A Supervisor will be permitted to guide Ph.D within the total number of **Eight** students from University of Madras and other Universities in Tamilnadu
3. A Supervisor shall **not** guide his/her immediate or close relative and to this effect he/she shall furnish a declaration in the column provided in the application form for admission. A supervisor shall not be permitted to register candidates for Ph.D. in the last one year of his/her service.
4. Whenever the Supervisors are transferred from their present place of employment to another place, the same should be intimated to the University, through proper channel, for approval of continuance of Supervisorship of candidates registered under them.
5. The Supervisors who wish to avail leave/lien/deputation beyond a period of **SIX MONTHS** shall nominate co-guides in the concerned subject for the candidates registered with them and the fact intimated to the University well in advance.
