Concerns of Programme Committee: On how many to perform, who to depend on for preparation (Mr. UnniKrishnan Maj. Porres will take final decision and inform Director 3 days before the event), on limiting the time of performance, on recording of the profiles of Judges, on the performance slot of Mr. Abishek and his team.... Discussions held but not confirmed.

2. **PRO Committee:** Mr. M.A. Jacob gave a flow Chart of the event thus. Accordingly he said the Banners, and Media activities artwork and adaptations Budget would cost around 20+.

The Banners (2 no's) were discussed and the Majority wanted the one with blue background. On branding the Logo of College of Excellence was suggested. On other Media Publicity the committee promised to provide the final framework before 12th Sept. and proceed with the publication, posting etc. About the paper Advertisement, a fixing with Times of India was presented by Fr. Director from the communication sent by Mr.VGP. Rajadoss. For the script on the Judges the support of Prof. Joseph Chandra (HOD English) could be sought. **Organisers to take the call.**

3. **Sponsorship:** Mr. Amith Kothari wanted to know on the costs of slots on the banners and Rs 50 thousands was fixed for a maximum of 10 nos.

4. **Food Committee:** Non- Vegetarian Dinner Menu was presented to the members from the hostel with costs from the Hostel. After discussion the members wanted menu to be limited to: 1.Mutton Biryani, 2.Chappathi, 3.Curd Rice, 4.Chicken Fry, 5.Curma, Veg. 6.Raitha, 7.Fruit, 8.Ice Cream, and 9.Water bottle. **Good plates and tissue paper to be used.** Lunch Venue: Whether it is Bertram Hall or elsewhere will be decided after receiving reasonable information on the participants' nos.

For the vegetarians digital library and the place in front of the same were considered to be insufficient but decision was not taken on the same.

6. **Registration committee/ Enrolment:** activities were discussed for a considerable time and the conclusions were: The timings proposed by the PRO

Committee, Programme Committee and Registration committee will be merged by Registration committee and finalised by the time of printing the Banner which will not be later than 15th Sept.

On Shamiyana, contacts would be made with Mr. Kasim of Ozone and the needed shamiyanas will be put at the spots thought of... Entrance (Arabian tent) Gate, Registration, Event centre for Spouses and Children, Lunch Areas as per decision which would come later etc.

Placement of Kits will be nearer to the Registration and Souvenir counter.

Kit will be provided after the Lunch.

Counters will be 7 (4 for Pre-Registered, 2 for Spot Registered and 1 for Life members)

7. Documentation: Documentation is regularly being done by the PRO to support this group. Mr. George B'Cherian promised of his support for the documentation as per the need.

Discussion was taken up on the ID Tags with two Samples presented. Further to the consultation made, the decision would be taken by the 15th of Sept. Instead of Flex banners Mr. George B'Cherian suggested **four sided boxes** and the members was positive and asked Mr. George B'Cherian to go ahead and present bills.

8. Reception Committee: A discussion on the activity of this committee pointed out the need to spell out the requirements like tables and other materials to the people concerned and get the work done.

9. Other Concerns:

- F. Payment based breakfast needs to be arranged and communicated.
